- b. The Opportunity School lease agreement with SD 308 is scheduled to be addressed at their June Board meetings for discussion and action.
- c. Joint Agreement Amendments will be presented at the June board meeting due to the recent Guidance document for Joint Agreements released in April of 2015 by the Illinois State Board of Education. HLERK is preparing the revisions regarding use of IDEA Part B Funds. Revisions will also have to be made to our recently adopted procedures for Policy 4:30 Revenue and Investments. Additionally, there has been interest by member districts in hiring social workers and psychologists or teachers, draft language is also being prepared for review of this change.
- d. A July meeting date is needed for the KCSEC Board to approve the IDEA grants, Budget and Joint Agreement Amendment. Lynda will be sending out dates to coordinate calendars to ensure a quorum.
- e. The Annual KCSEC Autism Institute for Teachers (Certified Staff) will be August 3-7<sup>th</sup> and the Paraprofessional Autism Institute on August 12<sup>th</sup> at the Oswego Fire Station. All member district staff are welcome and encouraged to participate.
