Individuals retiring on June of 2011 or June of 2012 must give a letter of intent to retire before 9/1/10 in order to receive the benefits as outlined in the Service Recognition Policy and Collective Bargaining Unit Agreement. There may be between 5 and 8 employees considering retirement that would fall under the benefit package mentioned above.
