  - c. Dissolution-Each district would be responsible for coming up with comprehensive plan for special education services that would be required for ISBE, and hire a state approved Director of Special Education. Current KCSEC certified staff would have the ability to be hired by one of the current member districts. There was a discussion regarding getting an Appraisal done on the Building and Adjacent property. Lynda will look into getting quotes for Appraisal.
